67.1 DECLARATION - members were given the opportunity to declare connection with items on the Agenda.

67.2 PLANNING ISSUES

67.2.1 Application No. 0/43985 Extension to dwelling at Bwthyn yr Afon, Llangernyw by Mrs Laura Rhys - RESOLVED unanimously to support the application.

67.2.2 Application No. 0/44062 proposed new Porch to front of existing dwelling house in Bwthyn y Nant, Vicarage Road, Pandy Tudur by Ms Trudi Stewart - RESOLVED unanimously to support the application.

Online applications - decided to write to Paula Jones, Head of Planning about a problem looking at applications online and to ask for hard copy applications.

67.3 BRO CERNYW FUND - Request from Bro Cernyw Sports Association. Elen Edwards expressed interest in the proposal. Decided to contribute £500 towards the project and to ask them to advertise to children of Bro Cernyw rather than Llangernyw. Need to advertise the sports project in the newsletter.

67.4 CONTRIBUTION BY PRESBYTERIAN CHURCH OF WALES TO MAINTAIN CEMETERY - the Clerk reported that she had received a check for £ 800 to the Maintenance of Seilo Chapel Cemetery and Garnedd Cemetery for the four years to 2017.
