4 MINUTES ARISING

EW raised that Arfon Parry had advised that last year's audit document is not on the website. It would appear that this document will be sent to the Council once BDO send this year's details back to the Council.

6 COUNCIL MATTERS

- 6.1** Council Rules: discussed these rules and the updated rules were accepted by the Council. AV proposed that these needed to be translated, EW seconded this.
- 6.2** Monetary Rules: discussed this document and the appendix, accepted by the Council. Discussed that this document needed to be translated as well, proposed by AV and seconded by DR.
- 6.3** Cemetery Rules: discussed and confirmed no updates required. The Council accepted the rules to be correct.

7 COUNTY COUNCILLOR'S REPORT

GLL reported that the County Council's work had recommenced following Covid-19. He congratulated EHE on her new position with the Council in the tourism department.

The upcoming months will be very challenging for the Council.

On a local level, he reported that remedial works on roads etc is being completed. The works near Bont Faen had commenced recently, discussions ongoing between the Council and Natural Resources Wales about raising the level of the wall to prevent future flooding.

EHE enquired whether GLL is aware of the funds available for 20mph signage near schools. GLL to make enquires for a sign for Llangernyw.

9 LOCAL MATTERS

REW raised that there is a pot hole in the road near Pant Llydan which has been there for two years. GLL had raised with the Council and will chase this up. GLL raised that the County Council had re-opened parks recently but not Gwytherin as there was damage there. EW had been to the park in Gwytherin before the meeting and had noticed that the sign and the lock had gone although they were there yesterday.

DR residents had enquired whether there was a possibility of locating the road signs near Hafodunos further out of the village. Also, no parking signs in the entrance of Fedwen Arian, GLL to make enquires.

EW had received messages from Gwytherin residents: Pennant, Hendre and Allt Felin Isaf roads surfaces had deteriorated, open stream in Dolfadyn field still had not been cleared following floods earlier in the year. EW will use Report It on the Council's website.

Also complaints about dog fouling in Gwytherin, lack of bins in the village. GLL to make enquires to site a bin in the village.

Ysgol Dyffryn Conwy had sent correspondence to parents of pupils starting year 7 in September that there will not be any transport. Clearly this will not be practical and is causing great worry and distress to parents. Plenty of notice will be required before September if parents are required to make alternative arrangements. GLL has asked for an urgent meeting of the education sector before September to discuss guidelines that will need to be implemented.

CR on behalf of GD drawing attention that Cronfa Bro Cernyw needs to be discussed separately from Council matters and needs to be noted as such in the minutes.
